THE SELECTED CANDIDATE WERE NOMINATED BY THE COMPENSATION COMMITTEE AND THEN APPROVED BY THE FULL BOARD. THESE ACTIONS WOULD HAVE BEEN RECORDED BY THE BOARD SECRETARY.
